Public Hearing

As the independent facilitator I am pleased to advise that the Public Hearing for the Kempsey Shire Council draft Plan of Management for Community Land was held at 5.30pm Tuesday 31 October at the Kempsey Civic Centre Community Room.

Director Robert Scott (Kempsey Shire Council) and co-author of the draft document Aisha Spokes (Momentum Project Solutions) presented at the Public Hearing. The meeting was attended by four residents of the Kempsey Shire Local Government Area, representing local sporting clubs (netball, cricket) and community land users.

Attendees were provided with a copy of the draft Plan and submission form.

Director Scott spoke with PowerPoint presentation about the draft Plan, legislative framework, categorisations, examples from the Schedules and the process for community engagement and submissions. Questions were raised from the attendees about site specific parcels of land at Kalateenee Reserve Dondingalong, and sporting fields (netball, cricket). Director Scott and Aisha Spokes answered and reviewed with the attendees the relevant schedules and explained the categorisations. All attendees indicated their positive support for the draft Plan.

The Public Hearing concluded at 6.15pm.
