#### **SORT TO SAVE**

Proper sorting of mixed loads that enable better resource recovery can, at the discretion of gate staff, result in a nominal discount. The discount is based upon the amount of materials sorted for resource recovery compared to the total amount of material being brought in.

#### **WASTE DEFINITIONS**

**Mixed Waste:** Material that in its final form at the point of disposal is unsorted, unseparated or contains material that necessitates disposal into the landfill.

**Construction and Demolition Waste:** Any waste sourced from the construction, remodelling or repair of individual residences, buildings and other structures that cannot be recycled on the site.

**Commercial and Industrial:** Any waste, either organic or inorganic, whose source is from commercial or profitable business sites.

**Inert Building Waste:** Concrete, bricks or stone over 150mm in any dimension capable of becoming a clean crushed aggregate resource.

**Green Waste:** Lawn clippings, garden waste, tree lopping's, plant material and untreated timber (but excluding stumps over 400mm in diameter, lantana and noxious weeds which will be charged at mixed rate)

Metal: Ferrous and non-ferrous scrap metal

Clean Fill: Clay, topsoil or gravel

**Special Burial:** Documents or other material needing immediate covering.

**Recyclables:** Includes clean paper/cardboard and empty containers (metal/plastic/glass)

Putrescible Waste: Waste that will decompose rapidly.
